

## Setting up your Digital Video Baby Monitor

## A. Connecting the power supply for the Baby Unit.



- Connect the USB plug of the power adapter to the Baby Unit and the other end to a suitable mains power outlet.
- Only use the enclosed adapter (5V DC/ 1000mA).
- Ensure the ON/OFF switch is at the "ON" position.

# ♠ WARNING:

Strangulation hazard. Children have STRANGLED in cords. Keep this cord out of the reach of children (more than 1 meter away). Do not remove the tags from the AC Adapters. Only use the AC Adapters provided.

#### B. Connecting the power supply for the Parent Unit.



- Connect the small plug of the power adapter to the parent unit and the other end to the electrical outlet.
- Only use the enclosed adapter (5V DC/1000mA).
- A rechargeable battery (Lithium-ion battery 3.8V/2000mAh) inside the Parent Unit allows you to move it without losing the link and picture from the Baby Unit. The battery gives up to 5 hours operation for the Parent Unit. We recommend you charge it for at least 16 hours before first use, or when the Parent Unit indicates the battery is low.
- Press and hold the POWER button  ${\color{red} o}$  on the top of the Parent Unit to turn it ON.

#### NOTE

When the Baby and Parent Units are both turned on and within range, the Parent Unit should show a color image from the Baby Unit camera, but if the room is dark, the image will be in black and white, with a 🜓 icon showing, due to the infra-red illumination by the Baby Unit.

## Basic operation of the keys

ტ	ON/OFF button	Press and hold to switch the Parent Unit ON/OFF.
<b>▲▼</b>	UP/DOWN buttons	Press to tilt the camera up or down. Press to move up or down menu settings.
<b>*</b>	LEFT/RIGHT buttons	Press to pan the camera left or right. Press to move left or right across menu options.
II.	MENU button	Press to open menu options or exit the menu.
OK	OK button	Press to confirm a selection.
Ð	VIDEO button	Press to turn the LCD screen ON/OFF.
<b>.</b>	TALK button	Press and hold to talk to your baby.
+	Volume buttons	Press -/+ to adjust the volume of the parent unit.
O RESET	RESET button	Press and hold with a small pin to reset the unit.

ON/OFF	ON/OFF switch	Slide the switch to the left to switch on the Unit. Slide the switch to the right to switch off the Unit.
Pair	PAIR button	Press and hold the button on the underside of the Baby Unit to register the camera to a Parent Unit.

#### Exclusions

**Normal Wear and Tear.** Periodic maintenance, repair and replacement of parts due to normal wear and tear are excluded from coverage.

**Batteries.** Only batteries whose fully charged capacity falls below 80% of their rated capacity and batteries that leak are covered by this Warranty.

Abuse & Misuse.
